# **DELEGATIONS**

# Ben Nygaard, Order - 515 Crawford Avenue East

Mr. Nygaard explained that he had planned to either sell the house at 515 Crawford Avenue East as a cabin, or demolish it himself in the spring of 2016; however, after he purchased the property he was notified of the demolition order deadline of October 31, 2015. Mr. Nygaard requested an extension of the deadline to May 30, 2016, in order to do the work himself. He assured Council that after the demolition the lot will either be levelled, or a basement built in 2016, in preparation for a new build in 2017.

# 15-195(a) Ponath Enge

#### **EXTEND ORDER - 515 CRAWFORD AVENUE EAST:**

That the Council of the City of Melfort grant a further extension of the deadline to comply with the Order to Remedy Contravention dated May 27, 2015, issued on 515 Crawford Avenue East, Lot 13, Blk/Par 65, Plan U1046, from October 31, 2015, to May 30, 2016, under the following conditions:

#### Michael Harold - City Landfill

Mr. Harold advised that this summer a collection of boats were dumped at the City landfill, one being a valuable boat from the '60s. He asked permission to purchase it, or make a donation to the women's shelter to remove it, but was denied and the boat was destroyed. He feels he was unfairly treated by Administration and commented that the City could be generating revenue at the landfill by reusing and recycling. There are landfills in the US that regulate scavenging.

Councillor Phillips pointed out that when an individual pays to dump private property at the landfill, it may be unethical for the City to resell it. Mayor Lang added that Administration is bound to follow Council policy, but requested that the issue be referred to the Works & Utilities for a cost-benefit analysis to determine whether it would be feasible to change the bylaw.

# Councillor Ponath - Brand Findings

Councillor Ponath, Chair of the Branding Team, described what branding is and the process undertaken following attendance at the Roger Brooks branding camp in April, 2014. Following a community survey and brainstorming our assets with Tourism Saskatchewan, the team identified what makes Melfort unique: great facilities (Palace and Wave Pool) and the community likes to get out and have fun, thus, the brand: Play Melfort. She noted that multigenerational travel will be an important financial boost to urban and rural markets such as ours. Once the Brand Committee has approval of the brand, they plan to start an awareness campaign and she hopes this will be considered a priority in the 2016 budgeting process. Council gave unanimous consent to adopt the brand, *Play Melfort*, and authorized the Committee to move forward with the branding process.
