#### **DELEGATION**

Saskatchewan Housing Corporation – Bemister Ave E Discretionary Approval

The Saskatchewan Housing Corporation attended the meeting as a delegation to present the building plan for a multi unit housing complex located at 300 Bemister Ave E. The SHC provided council with an explanation as to the concept of the multi unit residence being a safe living opportunity for people with disabilities in the City of Melfort. The building will also have 2 separate living areas that will be rented out at the discretion of the building lessee. The residents will be owned by the SHC and operated by Plus Industries as the lessee of the unit. The residential housing opportunities will be available to individuals with disabilities that meet the criteria set out by Plus Industries and the Ministry of Social Services. The City of Melfort current zoning bylaw requires discretionary use for this type of development in the designated zone, and application has been submitted for approval.

#### **Melfort Public Library**

The Melfort Public Library Board provided and overview of what the library does for the community, and the needs of the library to continue operating within and servicing our community. Board members provided and overview of future dreams for the library and the proposed feasibility study the city is set to conduct in 2022. The Library Board is requesting the opportunity for board members to be engaged in the process of the study and for the city to be willing to work with the board members to gain the best results from the study. The library has requested to have a meeting/fun event to discuss the matter with Council and provide all of Council an opportunity to attend the library to see what it has to offer.
