## 1. NORTHERN LIGHTS PALACE INTERIOR GROUT

The Committee of the Whole approved the increase in the scope of work for the pool tiling project, to include grouting the interior of the pool. Councillor Terry asked Administration to look back and determine why the pool was not grouted earlier.

## 2. 2021 PRELIMINARY OPERATING BUDGET

The City Treasurer reviewed the budget memo dated February 18, 2021, citing the changes in level of service implemented to address the projected deficit. The normal status quo budget has been reduced to remove items that are not necessary in a COVID year.

### a) General Operating Budget

- i) The Treasurer will check on salary coding between planning/rec admin.
- ii) Heritage Admin grants to organizations ensure one-time funding item from previous year was removed.
- iii) Rename unit line-item descriptions to 'lease amounts' where applicable.
- iv) Council may consider adding two seasonal positions for patching and cemetery maintenance.

## b) Utility Operating Budget

#### c) Landfill

- i) Check for coding issue between ground water testing and engineer consulting.
- ii) Review revenue and expenses for free usage at the landfill.
- iii) Recalculate percentage increases to budgeted expenses and revenues.

### d) Waste Collection

- i) Plus Industries' request was referred to Works & Utilities Committee.
- ii) Administration will obtain a list of the extra residential carts from Greenland and check to see whether the vehicle cameras can be used to measure volume.

## e) Special Levy - Medical Recruitment and Retention

The Treasurer will prepare scenarios for Council consideration to recoup the initial \$1.545 Million investment at the Wellness Centre, including a special tax levy, mill rate increase and base tax increase.

## 3. COMET FOOTBALL PARENTS' ASSOCIATION

The Committee of the Whole recommends that Council amend the Tax Receipt Policy to include the Comet Football Parents' Association as an eligible organization.
